

AIRBORN PURCHASE ORDER TERMS - U.S. FAR System and Supplement Clause Flow-Downs for U.S. Government Contracts

The clauses cited in the tables below, where applicable by their terms, are incorporated herein by reference as if set forth in full text. The effective version of each clause shall be the version currently in effect at the time of the order. If any of the clauses are not applicable by their terms they shall be self-deleting. Whenever said clauses include a requirement for the resolution of disputes between the parties in accordance with the "Disputes" clause herein, the dispute shall be disposed of in accordance with the clause entitled "Disputes" herein. "AirBorn" shall be substituted for or inserted after "Government", "United States", and "Contracting Officer" in the below clauses as necessary to give effect to the clause.

Seller agrees to negotiate with AirBorn to incorporate additional provisions herein or to change provisions as AirBorn reasonably deems necessary to comply with U.S. Government Contracts.

If so identified, this Order is a "rated order" certified for national defense use and Seller shall follow all the requirements of the Defense priorities and Allocation System Regulation (15 C.F.R. Part 700).
